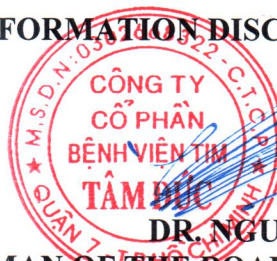

- Pursuant to the Enterprise Law No. 59/2020/QH14 passed by the National Assembly of the Socialist Republic of Vietnam on June 17, 2020;
- Pursuant to the Charter of Tam Duc Cardiology Hospital Joint Stock Company, approved by the General Meeting of Shareholders on April 28, 2022, and amended and supplemented on July 3, 2026;
- Pursuant to Resolution No. 01.2026/NQ-DHCD dated April 24, 2026 of the 2026 Annual General Meeting of Shareholders of Tam Duc Cardiology Hospital Joint Stock Company;
- Pursuant to Resolution No. VII.13.01/NQ-HDQT dated May 11, 2026 of the Board of Directors, Term VII, of Tam Duc Cardiology Hospital Joint Stock Company;
- Pursuant to Resolution No. VII.14.01/NQ-HDQT dated July 3, 2026 of the Board of Directors, Term VII, of Tam Duc Cardiology Hospital Joint Stock Company;
- Pursuant to the Minutes summarizing the opinions of the Board of Directors Term VII of Tam Duc Cardiology Hospital Joint Stock Company dated August 13, 2026.



RESOLUTION

Article 1. Approval of the reduction in the number of shares expected to be issued under the employee stock ownership plan:

The Board of Directors unanimously agrees to reduce the number of shares expected to be issued under the employee stock ownership plan from 700,000 shares to 690,000 shares and to amend and replace the implementation details of the issuance plan approved under Article 3 of Resolution No. VII.14.01/NQ-HDQT dated July 3, 2026, as follows:

1. Share name: Shares of Tam Duc Cardiology Hospital Joint Stock Company
2. Type of shares: Common shares
3. Par value per share: VND 10,000 per share
4. Number of shares expected to be issued: 690,000 shares.

Note: The number of shares expected to be issued is reduced by 10,000 shares compared with the number approved by the General Meeting of Shareholders because bonus shares will not be allocated to one employee who does not meet the eligibility criteria for participation in the program. these 10,000 shares shall be cancelled and shall not be distributed to any other person.

5. Issuance price: Not applicable (the Company awards shares to employees).

6. Total par value of the shares to be issued: VND 6,900,000,000.
7. Issuance ratio (number of shares expected to be issued/number of outstanding shares): 2.22%.
8. Source of funds (in the case of issuing bonus shares to employees): From the owner's equity based on the audited financial statements for 2025, specifically:
 - Using undistributed profit after tax: VND 6,900,000,000.
9. Transfer restriction: All bonus shares issued under the employee stock ownership plan shall be subject to a transfer restriction for one year from the end date of the issuance period.
The bonus shares issued shall not be recalled if an employee resigns during the transfer restriction period.
10. Expected issuance time: In the third quarter of 2026, after the State Securities Commission has issued a notice confirming its receipt of the complete issuance reporting documents.
11. Treatment of undistributed shares: If any employees refuse to receive the bonus shares allocated to them, such bonus shares shall be cancelled and shall not be redistributed to any other person.

All of the above contents are hereby amended and supplemented and shall replace in their entirety the contents set out in Article 3 of Resolution No. VII.14.01/NQ-HDQT dated July 3, 2026. All other contents of Resolution No. VII.14.01/NQ-HDQT dated July 3, 2026 shall remain unchanged and in full force and effect.

The Board of Directors, Term VII.15, unanimously approves the contents of this Article 1 with 100% of the votes and authorizes the Chairman of the Board of Directors to organize their implementation.

Article 2. Approval of the adjustment, amendment and supplementation of the List of employees participating in the employee stock ownership plan:

The Board of Directors unanimously approves the adjustment, amendment and supplementation of the List of employees participating in the employee stock ownership plan as provided in Article 2 of Resolution No. VII.13.01/NQ-HDQT dated May 11, 2026, specifically as follows:

- Cancellation of the allocation of 10,000 bonus shares to Dr. Kim Thanh Bao – Deputy Head of the General Planning Department.

Reason: The current position of Dr. Kim Thanh Bao does not meet the eligibility criteria for employees participating in the program as approved by the General Meeting of Shareholders for this issuance.

Article 3. Approval of the confirmation that the Company will not repurchase ESOP shares from employees and that no plan for the sale of repurchased shares will arise:

Pursuant to the Plan for Issuance of Shares under the employee stock ownership plan approved by the 2026 Annual General Meeting of Shareholders, the ESOP bonus shares issued shall not be recalled if employees resign during the transfer restriction period.

Based on the purpose and contents of the above-mentioned Issuance Plan, the Board of Directors confirms that, with respect to this issuance, the Company will not repurchase ESOP bonus shares from employees, including in cases where employees resign during the transfer restriction period. Therefore, there will be no repurchase by the Company of shares from employees and, therefore, no plan for the sale of any shares repurchased by the Company will arise.

The Board of Directors, Term VII.15, unanimously approves the contents of this Article 3 with 100% of the votes and authorizes the Chairman of the Board of Directors to organize their implementation.

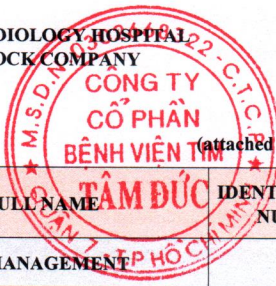
